The focus has remained communicating the benefits of a knowledge-based economy through programs like Science Cafe, sponsorships of innovative individuals and companies in the region, and our annual knowledge economy leadership conference, Engenuity Ignite

FY10 was marked by a federal grant from the Small Business Administration that focused on expanding entrepreneurial education programs like Fast Trac and K-12 Business Boot Camps. The grant also allowed us to focus on building more entrepreneurial support resources like the Midlands Entrepreneurship Resource Network and Entrepreneur After five (EAS). EngenuitySC also began work with the University of South Carolina, Midlands Technical College, the City of Columbia, and SC Launch to design and develop a region wide entrepreneurial support system that will be the focus of efforts in FY11

Hydrogen Fuel Cells The USC-Columbia Fuel Cell Collaborative was formed in 2005 by the University of South Carolina, the City of Columbia, EngenuitySC and the South Carolina Research Authority to position Columbia, SC as a leader in hydrogen fuel cell innovation and technology. In early 2010, Trulite announced the relocation of its corporate and manufacturing activities to the Columbia region, expanding presence and ramping up manufacturing and employment. In addition, Columbia welcomed NextGenEn, a solid oxide fuel cell start-up, Carolina Electrochemical, and Parallel Permeations
