The Adult volunteer literacy project exists to provide tutors for students learning to read, preparing for the GED test, or learning ESL. This program recruits and trains volunteers for one-to-one tutoring and small groups, providing both individual attention as well as group learning opportunities in supplemental programs such as health literacy, financial literacy, math class and others. Hundred of volunteers are trained annually, and their skills enhanced to meet the students' needs

Through classes in basic reading, GED preparation, Workforce preparation incumbent worker program, and ESL, Literacy Chicago served over 1000 adult learners throughout the chicagoland area. These programs have qualified paid instructors and the classes are adapted to the needs of the site and program, though most are 12 week sessions. These classes are achieved in part because of strong collaborations with other nonprofit and community based organization
