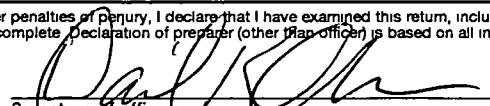
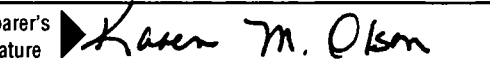

OUR RESIDENTIAL PROGRAM IS DESIGNED TO ADDRESS THE COMPLEX NEEDS OF VICTIMS OF DOMESTIC VIOLENCE WHO ARE AT ALL STAGES OF A CONTINUUM, FROM THE CRISIS STAGE WHERE THEY MAY BE ADDRESSING THE VIOLENCE IN THEIR LIVES FOR THE FIRST TIME, TO THOSE READY FOR SELF-SUFFICIENCY AND INDEPENDENT LIVING. WHILE IN SHELTER, WOMEN PARTICIPATE IN A COMPREHENSIVE RANGE OF SERVICES INCLUDING INDIVIDUAL, GROUP, AND FAMILY COUNSELING, CASE MANAGEMENT, LEGAL ADVOCACY, EMPLOYMENT ASSISTANCE, FINANCIAL LITERACY CONSULTATION, PARENTING SKILLS TRAINING AND SUBSTANCE ABUSE SERVICES. ADDITIONALLY, THE SHELTER PROGRAM PROVIDES CHILDREN WITH THE OPPORTUNITY TO HEAL FROM THE EMOTIONAL TRAUMA THEY HAVE EXPERIENCED, AS THEY BUILD A HEALING RELATIONSHIP WITH COUNSELORS AND BUILD A SUPPORT NETWORK WITH OTHER CHILDREN.

WOMEN AND CHILDREN WHO ARE NOT RESIDING IN THE SHELTER PROGRAM AND FORMER SHELTER CLIENTS SEEKING AFTERCARE SERVICES MAY ACCESS COUNSELING AND CASE MANAGEMENT SERVICES THROUGH OUR NON-RESIDENTIAL COUNSELING PROGRAM. THIS PROGRAM OFFERS INDIVIDUAL, GROUP, AND FAMILY COUNSELING AND CASE MANAGEMENT SERVICES FOR WOMEN AND CHILDREN IN ENGLISH AND SPANISH. THE FOCUS OF THE COUNSELING PROGRAM IS TO HELP CLIENTS LEARN TO MITIGATE THE EFFECTS OF THE TRAUMA BY GIVING THEM AN EMOTIONALLY SAFE PLACE TO PROCESS THEIR DOMESTIC VIOLENCE EXPERIENCES. CURRENT GROUPS INCLUDE WOMEN'S SUPPORT GROUP, DOMESTIC VIOLENCE EDUCATION GROUP, PARENTING SUPPORT GROUP, NEXT STEPS CASE MANAGEMENT GROUP, AND THE POPULAR MOM AND KIDS GROUP, WHICH IS DESIGNED TO SERVE BOTH MOTHERS AND THEIR CHILDREN SIMULTANEOUSLY. ADDITIONALLY, OUR CLIENTS HAVE

THE COMMUNITY ADVOCACY PROGRAM ENCOMPASSES THOSE SERVICES THAT ARE DIRECTLY ACCESSIBLE BY THE PUBLIC: HOTLINE, COURT ADVOCACY, MEDICAL ADVOCACY AND THE PEACE PROJECT (PREVENTION, EDUCATION AND COMMUNITY ENGAGEMENT). THE 24-HOUR HOTLINE CONNECTS CALLERS TO CRISIS INTERVENTION AND ACTS AS A GATEWAY TO COUNSELING AND RESIDENTIAL SERVICES. THE COURT ADVOCACY PROGRAM, LOCATED AT THE DUPAGE COUNTY COURTHOUSE, PROVIDES ASSISTANCE AND SUPPORT TO PEOPLE SEEKING ORDERS OF PROTECTION. MEDICAL ADVOCATES FORGE CONNECTIONS WITH HEALTH CARE PROVIDERS IN OUR COMMUNITY TO ENSURE THAT VICTIMS OF ABUSE ARE SCREENED AND PROVIDED WITH NECESSARY REFERRALS.
