**Housing- includes Housing Counseling & Home Sharing which provides clients with potential housing options, such as the homesharing program, Housing Choice voucher placements, senior housing applications, landlord and realtor negotiations, referral to low-cost apartments, referral to shelters and single room occupancy sites, facilitation of referrals to other agencies, and accessing financial assistance. 2,600 clients were served.**

**Also, Transitional Housing which provided shelter, case management, mental health and other supportive services to homeless families and individuals to help work toward self-sufficiency. 4,680 shelter nights were provided to 22 clients.**
