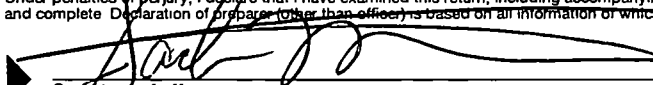
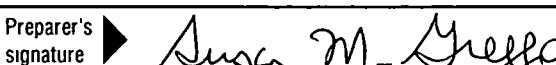

THE CORE SERVICES PROGRAM PROVIDES DIRECT JOB PLACEMENT ASSISTANCE TO YOUTH AGES 14-25. THIS YOUTH JOB CENTER ("YJC") PROGRAM IS THE "ANCHOR" OF ALL YJC PROGRAMS. IN FY 2010, CORE SERVICES SERVED APPROXIMATELY 900 YOUNG JOB SEEKERS. THE OUTPOST, YJC'S SATELLITE OFFICE AT EVANSTON TOWNSHIP HIGH SCHOOL, IS AN EXTENSION OF CORE SERVICES SPECIFICALLY DESIGNED TO PROVIDE ACCESS TO EMPLOYMENT OPPORTUNITIES TO "IN-SCHOOL" STUDENTS. THE YJC OUTPOST IS A MAJOR ACHIEVEMENT BECAUSE IT IS THE ONLY JOB PLACEMENT OFFICE TO BE LOCATED WITHIN A HIGH SCHOOL. EACH YEAR, THE YJC OUTPOST PROVIDES JOB-READINESS AND JOB PLACEMENT SERVICES TO AN ADDITIONAL 350 HIGH SCHOOL STUDENTS. CORE SERVICES ALSO OFFERS WORK EXPERIENCE OPPORTUNITIES TO OUR YOUNGEST JOB SEEKERS, AGES 14-15, THROUGH YJC'S

THE OUT OF SCHOOL YOUTH PROGRAM (OOSY), A WORKFORCE INVESTMENT ACT FUNDED PROGRAM IN PARTNERSHIP WITH THE WORKFORCE BOARD OF NORTHERN COOK COUNTY, PROVIDES INTENSIVE EMPLOYMENT AND RELATED SERVICES TO AT-RISK YOUTH AGES 18-21 WHO FACE MULTIPLE BARRIERS TO EMPLOYMENT. THROUGH THE OOSY PROGRAM QUALIFIED PARTICIPANTS MAY ACCESS TRAINING FUNDS FOR CONTINUING EDUCATION AND/OR VOCATIONAL TRAINING ACTIVITIES THAT LEAD TO A STATE CERTIFICATION OR CREDENTIAL. IN FY 2010, THE OUT-OF SCHOOL YOUTH PROGRAM PROVIDED JOB PLACEMENT AND COUNSELING SERVICES TO APPROXIMATELY 116 YOUTH AND AWARDED MORE THAN \$23,000 IN TRAINING VOUCHERS. OF THE 116 YOUTH SERVED THROUGH OOSY, 87 WERE PLACED INTO JOBS. THE YJC WAS ALSO THE ONLY EVANSTON-BASED ORGANIZATION TO BE AWARDED ARRA (AMERICAN RECOVERY AND REINVESTMENT ACT-STIMULUS) FUNDS

SINCE 1998, OUR STRATEGIC CORPORATE ALLIANCES PROGRAM, (SCA) HAS PROVIDED JOB PLACEMENT AND TRAINING SERVICES TO MORE THAN 1,000 CHRONICALLY UNEMPLOYED AND UNDER-EMPLOYED YOUNG PEOPLE, AGES 18-25. PARTICIPANTS IN THE THREE-WEEK PROGRAM RECEIVE INTENSIVE JOB-READINESS, CAREER COUNSELING AND BASIC COMPUTER SKILLS INSTRUCTION. THE GOAL OF THE PROGRAM IS TO PLACE GRADUATES OF THE PROGRAM INTO IN FULL-TIME, LIVING WAGE JOBS WITH EMPLOYEE BENEFITS AND CAREER POTENTIAL. IN FY10, 100 YOUTH WERE SERVED.
