To receive and maintain a fund or funds and to use and apply and use said funds exclusively for charitable, educational and scientific purposes and in particular, for the benefit, improvement and welfare of Marcus Daly Memorial Hospital, and its patrons by providing funds for buildings, equipment, special programs, furnishings and other items useful or beneficial to the operations of Marcus Daly Memorial Hospital. The Foundation is dedicated to ensuring that Marcus Daly Memorial Hospital has the best facilities and services for the residents of Ravalli County now and in the future. In the furtherance of this goal the Daly Hospital Foundation was able to contribute \$25,000 towards the purchase of a used ambulance, \$33,645 for a Cardiac Management Computer System and \$23,499 towards the purchase of a bariatric bed for the nursing floor. Contributions were made to purchasde equipment in the Emergency, Physical Therapy and Nursing Departments totaling \$17,803. The Foundation raised nearly 100,000 to support equipment purchases for various departments of Marcus Daly Memorial Hospital.
