The Foundation views soccer as a powerful vehicle for youth development and social change and focus our grants on programs and projects that improve the health and well-being of children in economically disadvantaged communities Grants were awarded to 41 soccer-related organizations for a variety of purposes including - Field Building Engaging community-based organizations and local non-profits, the Foundation provided 20 grants to develop and equip quality soccer fields that provide children with safe places to play and to lead healthy active lives - Program Building 21 Grants were also provided to support the development and expansion of soccer programs with strong youth development components Areas of emphasis include programs that -Provide children with guidance on nutrition and ways to stay active and healthy to help combat rising childhood obesity rates, -Engage children in academic activities with the goal of increasing educational attainment, -Work to guide children away from negative influences such as gangs and violence Finally, the Foundation's Passback program collected over 171,000 pieces of new and gently used soccer equipment that was redistributed to various soccer programs in economically disadvantaged communities
