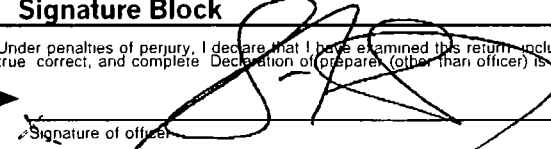
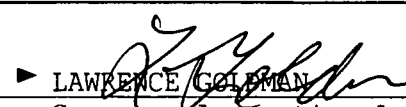

history, government and civics with digital age technology and community
involvement to educate, engage and empower middle-grade students to be
participative citizens in their communities and make reasoned commitments to
the core democratic values of the United States.

In 2009/10, the after school program which engages a student in learning about
the fundamentals of our democratic society in the context of community involvement
was in 16 sites and engaged more than 150 students.

The Foundation developed and administers Teaching with Primary Sources,
an educational program as one of 26 national partners with the Library
of Congress. The program has successfully engaged over 2,500 teachers and

workshops and online curriculum has engaged teachers across Illinois.
