Family programs help at-risk families function successfully in teh community by providing social, health, emergency and educational resources. Programs include counseling, disaster services, legal services, emergency shelter and parenting skills that focus on: counseling and case management that develop skills which lead to stable lifestyles, provide immediate crisis support for families in need, training and support that help family members become better parents and provide legal support that allows families to be secure and stable.

Part III, 4d - Self-reliance programs help at-risk people live on their own by helping them gain the skills they need to get through life. Programs include counseling, employment services, life skills, food pantries, emergency assistance and transitional housing that focus on: providing supportive housing that is affordable and helps mitigate factors that lead to homelessness such as low income, substance abuse, health issues, and aging. Create financial stability through education and employment services such as job preparedness and training. Optimize services for individuals such as seniors and the developmentally disabled so they can continue to live independently.

Community in Schools is a collaborative program between Peoria Public Schools and Heart of Illinois United Way partner agencies that administers substance abuse, violence prevention and mental health programs for students in kindergarten through high school. The program focuses on mental health screening and counseling, substance abuse prevention and abeyance case management.

Part VI, Section A, 6 and 7a - The Heart of Illinois United Way has 47 partner agencies who receive funding for 104 programs through a competitive grant process. The partner agencies elect the Board of Directors each year at the annual meeting

Part VI, Section B, 15 - At the beginning of each fiscal year, staff fills out a report with goals and objectives outlined for the fiscal year. At the end of the year, staff responds to their goals and objectives and immediate supervisor also responds to goals and objectives. Merit increases are based on how well the employee did at meeting or exceeding these goals and objectives established at the beginning of the fiscal year. Each position has a salary range that is updated based on current pay studies and employee pay rates are based on these ranges.
