Meals: Home Sweet Home Ministries operates a full-service cafeteria at the Billy Shelper Center which prepares and serves three meals daily (over 88,000 meals this year) to residents of the center as well as those who walk-in from the street. All meals are well-balanced, meet USDA guidelines and are prepared by trained and licensed staff. Volunteers are frequently used to help serve meals. A large portion of food served comes from individual and restaurant donations.

In addition to residential and non-residential meals, Home Sweet Home Ministries provides emergency food boxes to non-residents and sack lunches for residents who work during meal times.

4b (Code:) (Expenses \$ 476,219 including grants of \$) (Revenue \$)

Temporary Services: Home Sweet Home Ministries operates a 24 hour, year round residential care program within the Billy Shelper Center (95 bed capacity) with ten beds reserved for Veterans. There are separate rooms for families with children. In addition to meals, residents at the center receive toiletries, showers, clothing, counseling, Christian ministry, as well as many other social services. During a short-term stay, individuals and families are matched with a caseworker who assists in many areas, including housing, locating childcare, and employment. This year, Home Sweet Home Ministries provided more than 25,000 nights of shelter to persons in need.

Threshold Program: Threshold is a long-term residential program of Home Sweet Home Ministries devoted to helping individuals overcome chronic barriers to independent living. The program ranges from 9 to 13 months in length depending on individual needs. Students live full-time at the Billy Shelper Center and participate in an education-based curriculum targeting their individual needs. The program focuses on building and strengthening educational, social, and vocational skills, family reconciliation, personal growth, and spiritual enrichment.

The Organization is organized as an Illinois not-for-profit corporation and is exempt from federal taxation under section 501(c)(3) of the Internal Revenue Code. The Organization is also registered with the State of Illinois Attorney General under the Charitable Trust and Solicitation Act and has been given a religious exemption from the annual filing requirements. The Organization files a Form 990 (Return of Organization Exempt from Income Tax) annually. When the returns are filed, it is highly certain that some positions taken would be sustained upon examination by taxing authorities, while others are subject to uncertainty about the merits of the tax position taken or the amount of the position that would ultimately be sustained.

Examples of tax positions common to nonprofit organizations include such matters as the following: the tax exempt status of each entity and various positions relative to potential sources of unrelated business taxable income (UBIT). UBIT is reported on Form 990-T, as appropriate. The benefit of tax position is recognized in the financial statements in the period during which, based on all available evidence, management believes that it is more likely than not that the position will be sustained upon examination, including the resolution of appeals or litigation process, if any.

Tax positions are offset or aggregated with other positions. Tax positions that meet the "more likely than not" recognition threshold are measured as the largest amount of tax benefit that is more than 50% likely to be realized on settlement with the applicable taxing authority.
