The National Council of Teachers of English is devoted to improving the teaching and learning of English and the language arts at all levels of education. This mission statement was adopted in 1990. The Council promotes the development of literacy, the use of language to construct personal and public worlds and to achieve full participation in society, through the learning and teaching of English and the related arts and sciences of language.

Professional Meetings and Seminars. NCTE hosted fewer “live” meeting events in FY10 but introduced more “virtual” events and services that allowed registrants to connect digitally without the time and expense of travel. Remarkably, despite the fact that we held fewer meetings and saw reduced school funding support for teacher professional development, our meetings remained very active and profitable this year. Nearly 1,300 more people registered for the 2009 NCTE convention in Philadelphia than had attended the 2008 convention in San Antonio (6,893 v 5,598). The CCCC Convention for college level teachers of writing was somewhat smaller in 2009 than in 2008 (3,260 v 3,557), but this may be attributed to a smaller meeting venue (Louisville vs. San Francisco). Overall, our meetings and seminars generated \$2.37 million in revenue and a profit in excess of \$731,000.

Professional Journal and Periodical Publications. The Council extended its rich tradition of publishing original, peer-reviewed research on literacy education and perspectives on current issues in teaching and learning through its periodical publications program. Through eight peer-reviewed journals and four quarterly or semi-annual newsletters, NCTE released 50 issues during FY10 covering the waterfront of critical issues in literacy education—from early literacy acquisition practices, through engagement of adolescent literacy learners, to in-depth analyses of systemic reforms and original contributions to humanities scholarship. Periodical publishing continues to serve as a financial pillar for NCTE, earning \$1.869 million in revenue and a profit of nearly \$603,000.

Nonperiodical Publications/books. NCTE published or co-published 22 peer-reviewed books this year, doubling the number of books released in FY09. The sales impact of this increased activity was muted by the fact that most of the books for our largest market segment (secondary) came out at the very end of the year. Still, the range of topics addressed is impressive—from timely issues like dual-credit for college in high school, to new twists on traditional challenges like teaching Julius Caesar or engaging adolescent literacy learners. As has been the case for the Council through most of the past two decades, our book publishing program generated a financial loss; the deficit on book publishing was just over \$197,000 this year, slightly smaller than last year’s. Still, the program provides a service to our membership and wider professional community and there is cause for optimism in the quality and timeliness of titles released at year’s end.
