NOTE 1 — Summary of Significant Accounting Policies

Nature of Activities:

Northeast Oregon Network (Organization) was incorporated in Oregon on April 13, 2009, under the State of Oregon Non-Profit Corporation Statutes. The Organization seeks to increase access to integrated health care for Northeast Oregon residents by identify system gaps, facilitating community developed solutions, and advocating for health policy change.

Financial Statement Presentation:

The Organization has adopted Statement of Financial Accounting Standards (SFAS) No. 117, *Financial Statements of Not-for-Profit Organizations*. Under SFAS No. 117, the Organization is required to report information regarding its financial position and activities according to three classes of net assets: unrestricted net assets, temporarily restricted net assets and permanently restricted net assets.

Promises to Give and Contributed Services:

During the year ended June 30, 2010, the value of promises to give and the value of contributed services meeting the requirements for recognition in the financial statements were not material and have not been recorded.

Accounts Receivable:

All of the Organization's accounts receivables are balances due on signed grant agreements. Although the Organization uses the allowance method for doubtful accounts, there were no accounts at June 30, 2010 which management considered uncollectible.

Fixed Assets:

Property and equipment are capitalized at cost, except for donations, which are recorded as contributions at their estimated fair value. Such donations are reported as unrestricted contributions unless the donor has restricted the donated asset to a specific purpose. Assets donated with explicit restrictions regarding their use and contribution of cash that must be used to acquire property and equipment are reported as restricted contributions. Absent donor stipulations regarding how long those donated assets much be maintained, the Organization reports expiration of donor restrictions when the donated or acquired assets are placed in service as instructed by the donor. The Organization reclassifies temporarily restricted net assets to unrestricted net assets at that time. The Organization depreciates property and equipment using the straight-line method over the estimated useful lives of the assets. Estimated useful lives usually range from five to seven year for furniture, fixtures, computer equipment and vehicles.

Income Taxes:

The Organization is a not-for-profit organization that is exempt from federal and state income taxes under Section 501(c)(3) of the Internal Revenue Code and similar state provisions.

Cash and Cash Equivalents:

For purposes of the statement of cash flows, the Organization considers all highly liquid investments available for current use with an initial maturity of six months or less to be cash equivalents.

Functional Allocation of Expenses:

Costs of providing the various programs, services and other activities have been summarized on a functional basis in the statement of activities. Accordingly, certain costs have been allocated among the various programs and supporting services.

Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

NOTE 2 — Certificates of Deposit

A certificate of deposit in the amount of \$100,247 is included in cash in the accompanying financial statements. The certificate bears interest at 1% per annum and has a six month maturity, with penalties for early withdrawal. Any penalties for early withdrawal would not have a material effect on the financial statements.

NOTE 3 — Contingencies

Amounts received or receivable from outside agencies are subject to audit and adjustment by those outside agencies. Adjustments in amounts claimed as allowable program expenses may result in a future liability of the Organization.

NOTE 4 — Retirement Plan

The Organization maintains a defined contribution plan under the Internal Revenue Code's Savings Incentive Match Plan for Employees (SIMPLE Plan). Employees are eligible to participate in the plan upon employment with Northeast Oregon Network. The plan allows employee contributions of up to \$11,500 each year. Employee contributions are fully vested. The employer will match up to 3% of eligible employee contributions to the plan. For the year ended June 30, 2010, contributions to the plan were based upon eligible payroll of \$166,028, and total employer contributions to the plan were \$4,841.

NOTE 5 — Compensated Absences

Northeast Oregon Network maintains a deferred compensation personal leave plan. All full-time employees are eligible and begin to accrue vacation pay on their first day of employment. Accrued vacation cannot be used until after a 90 day orientation period. Vacation pay is accrued at 8 hours per month for full time employees. Part-time employees earn prorated vacation pay based on their normal work week. As of June 30, 2010, accrued vacation pay totaled \$6,449. Under the terms of the Organization's policy, the maximum hours allowed to be accrued is 240.

NOTE 6 — Concentrations of Credit Risk

The Organization maintains depository accounts in Union Wallowa Baker Federal Credit Union and the balances are insured by the Federal Deposit Insurance Corporation up to \$250,000. At June 30, 2010, the Organization had an uninsured cash balance of \$0.
