The University of Illinois has 639,000 living alumni. The Alumni Association provides support services to assist the Chicago, Springfield and Urbana-Champaign campus alumni relations efforts. These professional services include event planning, organizing and assisting alumni clubs, chapters and special interest groups, career counseling, and counsel on alumni relations. The Alumni Association provides these services through its campus offices in Chicago, Springfield, Urbana and the Alumni Career Center at the Illini Center in downtown Chicago. The Alumni Association also manages the Alice Campbell Alumni Center in Urbana with a variety of spaces available for events.

The Alumni Association is responsible jointly with the University of Illinois Foundation for the primary management and stewardship of the University of Illinois alumni records. The Alumni Association endeavors to record and honor the communications preferences of alumni. The result is more effective and efficient two-way communication between alumni and the University. The Alumni Association adds an estimated 11,000 to 15,000 new alumni degree records to the database when received from the University of Illinois. Each month, a change of address review is performed on approximately 1.1 million records of alumni, donors and friends of the University. Each year an estimated 60,000 phone numbers are added or updated. Based upon requests from the University, alumni or the Alumni Association staff, there are updates of an estimated 628,000 or more alumni and donor records, and a significant number of reports and analyses produced. In addition, the Alumni Association operates a website at www.uiaa.org and provides a web-based directory and network for operation by alumni groups, the University of Illinois Alumni Network.

The Alumni Association produces a wide variety of communications about the University of Illinois and its alumni. The Alumni Association provides 4-6 issues per year of its alumni magazines for each of the three major campuses of the University of Illinois. The magazines are mailed to alumni life members and sustaining members (i.e., those that have met contribution criteria to the Alumni Association). The annual magazine circulation totals are estimated at 64,000 for Urbana, 16,000 for Chicago and 2,000 for Springfield. Monthly e-newsletters are provided to all alumni that provide an e-mail address to the Alumni Association. The annual e-newsletter circulation totals are estimated at 108,000 for Urbana, 60,000 for Chicago and 9,000 for Springfield. The Alumni Association's website receives an estimated 54,000 unique visitors each month. The Alumni Association also sends targeted, special topic e-mails to alumni segments throughout the year.

There are typically 4 to 5 metrics, 2 to 3 are typically based upon the Alumni Association's revenues in key categories, and 1 to 2 are based upon individual performance, and in certain instances, the Alumni Association's non-financial performance in a key activity pertaining to its mission goals and objectives.
