Each year, following a specific formula, the Pine Rest Foundation awards grants to the Pine Rest Chrstian Mental Health Services to fund various aspects of behavioral health care and counseling programs. An award of \$454,353 was made to provide funds for financial assistance for patients with inability to pay for services. An additional \$417,870 was made available for education, prevention and support programs through the Day Programming for those with developmental disabilities, support groups and services. A Job Support and Career Exploration Program was funded for emotionally disturbed adolescents in the residential program. Critical services funding was provided for 24-hour Critical Incidence Response Team services. Funding was also provided for the clinic network to implement best practices and perform outcome evaluation, specifically using the latest treatment protocols for an Effective Treatment for Autism as well as Depression Care for Cardiac Patients. A number of research, development and training programs were also funded.

Annual Golf Classic Fund Raiser.
