	During 2009-10 the Tavern League of Wisconsin lobbied on twenty-six legislative bills that would impact its members. The Association also published six bi-weekly magazines and twelve monthly newsletters and held two conferences as well as a legislative day and a league leader day. The Association established an "exclusive member benefit program" that currently has twenty affiliate members. The Association also distributed 5,000 free drug cards to its members and partnered with Dean Health Systems, Inc. and WPS Health Insurance to provide a major medical insurance program.
