Child Education Renewal Unlimited, Inc provides educational services for children between the ages of infancy and entrance into kindergarten The educational services are provided in both a center-based setting and in a Homebased setting For the center-based setting, children attend licensed child care facilities that provide comprehensive Head Start services The classes range from 3 5 hours per day to 5 hours per day The educational services are provided to meet the individualized needs of the children and cover the areas of gross and fine motor skills, math, science, reading, literacy, social-emotional development, and pre-writing skills The Homebased program provides services in the home setting of the infant/child and has a primary goal of teaching the parent to become their child’s first and foremost teacher Over 600 children are served through child education services

Housing and Rehabilitation Through the HOME Program, Renewal is able to provide a second mortgage to income eligible homebuyers at a 0% interest rate and that is deferred until the homebuyer either sells the property or no longer lives in the home as their primary residence This method basically buys down the primary mortgage so that the payments on the primary mortgage are more affordable for the homebuyer Through a sub-contract with Central Wisconsin Community Action Council, current homeowners and potential homebuyers who meet income eligibility guidelines can have rehabilitation completed to make the homes they are currently living in or that they are looking at buying to meet minimum housing standards for safety and habitability The HCRI Program offers down payment and closing cost assistance to potential homebuyers Housing programs provide services to over 100 individuals and families

Community Services Renewal provides a variety of services to the community including services to low income infants, toddlers, and pre-school age children through the Early Head Start and Head Start Program, at-risk youth services through the In-School Youth Program and the Fresh Start Program, services to prevent child abuse and neglect through the multiple services offered at the Family Resource Centers, housing services to assist renters and homeowners maintain an affordable unit or prevent foreclosure, and services to families to strengthen each family unit to gain/maintain self-sufficiency These services are provided free of charge to individuals and families throughout the counties of Adams, Columbia, Dodge, Juneau, and Sauk Renewal works collaboratively with many other community agencies to enhance services that are available to low to moderate income families and yet avoid duplication of services Renewal also provides resources to families to help meet individualized needs that are identified Referral services to other agencies are made as appropriate Community service programs serve approximately 600 individuals and families
