One of the organization's goals is to develop and influence legislation and policy affecting member firms' business. The government advocacy program has grown and we continue to move qualifications-based selection procurement legislation forward. The grassroots efforts this past year, with more than 300 contacts made with state legislators, was helpful, although the legislation failed to pass. We were successful in our grassroots efforts to defeat legislation that could have significantly impacted business negatively for the industry. Most legislative offices were contacted by the membership.

Another goal is to improve the business environment for member firms. We continued to organize annual conferences for consultants working for state agencies and to help the state communicate its concerns and issues to work together in partnership. In addition to quarterly meetings between liaison committees and state agencies, two large conferences were organized. In October 2009, over 260 registrants attended the Division of State Facilities Consultants Conference. It marked the 18th year of this event. Almost the same number of participants attended the Division of Transportation Conference held in March 2010. This conference was the third annual meeting organized by the organization with continued attendance growth.

A third organizational goal is to provide a strong educational program focused on member needs. The cornerstone of our educational efforts is the Engineering Future Leaders Program. Economic conditions limited class size, however, eleven design professionals attended more than seventy hours of professional development programming learning about leadership and the consulting engineering profession.
