Assist dislocated workers via assessment, case management, referral to employment and training programs and assistance with job placement in the State of Wisconsin. Approximately 4,952 dislocated workers received services with an approximate 75% entered employment rate.

Workforce Investment Act (WIA) funds are utilized to provide outreach and case management services to assist, train and place dislocated workers into employment. These services are provided within the existing Job Centers established in the State of Wisconsin.

4b (Code) (Expenses \$ 81,209 including grants of \$) (Revenue \$ 91,712)

Two educational sessions were conducted to provide vocational training and coaching skills for newly dislocated workers. The sessions were held at two different plant closing locations across the State of Wisconsin. The skills taught enabled the newly dislocated workers to in turn provide the training to the remainder of the workers affected in the respective plant closing locations.

Nine training sessions were conducted to provide training in four modules of manufacturing skills. The modules included: safety, quality, manufacturing processes and maintenance. Training time for each module is 48 hours. The sessions were held in southern Wisconsin. Approximately 93% of trainees achieved the objectives, as measured on a post test.

One session was conducted to provide skills training to 36 members of the Hispanic population. 34 trainees successfully completed the program.
