The 2009-2010 academic year enrollment was 645 full-time equivalent (FTE) students in the Fall Semester and 595 FTE students enrolled in the Spring Semester. Of the total number of students enrolled in 2009-2010 academic year, 146 met the requirements of graduation.

Student Services & Academic Support: Bethany boasts a long-standing commitment to educating the whole person by nourishing the intellectual, spiritual, emotional, social and physical dimensions of students' lives. The College offers a curriculum that challenges students to think critically and express themselves effectively, a campus life that encourages involvement and service (over 20 student organizations), a community of faith that nurtures spiritual growth and develops moral responsibility, and co-curricular activities that inspire students to test their own limits and express their individuality.

Auxiliary enterprises at Bethany Lutheran College provide 5 residence halls on campus, 2 dining venues, and a bookstore for students, faculty and staff.
