Food Shelf - The Duluth Emergency Food Shelf provides five-day food packages to households without food or the resources to obtain food CHUM operates two food shelf locations in downtown Duluth and in West Duluth In 2009, 2,185 households (unduplicated) including 13,711 individuals received assistance through CHUM's Duluth Emergency Food Shelf program

Drop-In Center - The CHUM Center serves as a resource center, program space and community living room for very low and no-income people who are often homeless or in crisis or need Social workers provide assistance on a drop-in basis The Center operates the Nurse's Clinic and Hope Clinic, the Supportive Services for Employment Program, SSI application assistance, and housing advocacy Nearly 1,800 people (unduplicated) received services from professional staff in 2009 The Center also provides laundry and shower facilities, voice mail, and is a mailing address for those who are homeless Lunch is provided Tuesdays and Thursdays and meals are served at special events The Center is a gathering space for people to socialize, read, watch television and otherwise escape the isolation of homelessness or small rooms and apartments Public events including poetry readings, music performances, public forums, etc are held at the Center throughout the year

Emergency Shelter - CHUM operates both congregate (individual) and family shelters as well as transitional housing (3 units) and permanent housing with supportive services (4 units) Those served are homeless and very low and no-income CHUM's congregate shelter provides 46 beds in a dormitory setting CHUM's family shelter has four apartments Guests must work closely with the housing advocate or case manager with the goal of obtaining permanent housing as quickly as possible Ongoing stabilization assistance is available to help former guests maintain permanent housing In 2009 the Emergency Shelter Program served 836 individuals (unduplicated) including 61 families
