In fiscal year 2010, Plains Art Museum served 42,746 visitors of all ages through high quality art exhibitions, educational programs, live music, and outreach activities. The museum organizes six to eight major exhibitions annually with an equal number of smaller exhibitions. The museum's permanent collection of 3,300 objects is also used for special exhibitions and research, occasionally shown in national and international venues. Exhibitions focus on artists in the community and region. The permanent collection focuses on 20th and 21st century American art, regional art, and work by Native American artists. In fiscal year 2010, the museum presented the following exhibitions: *Drawings by Frank Big Bear*Day of the Dead Latino artists create steamroller prints*Stories of the Somali Diaspora photographs by Abdi Roble*Individual to icon Portraits of the famous and almost famous from folk art to facebook*16th annual national Juned Watermedia Exhibition*Modern Man presents Andy, you used me*. In addition, the museum presented a number of exhibitions in its ancillary spaces.

In-house education programs include docent-led tours, lectures, artist talks, curator-led gallery talks, internships, art camps and art classes and workshops for children and adults.
