

Life Work Planning Center is a well established, regional organization providing services to displaced homemakers and women in transition. The mission of the agency is to increase the emotional and economic self-sufficiency of women and their families.

The DH grant provides pre-employment and peer counseling services to displaced homemakers who live in south central Minnesota. Services include workshops, individual peer counseling, testing and assessments, advocacy, resources and referrals, and direct client assistance as appropriate. LWPC served 139 displaced homemakers through this program last fiscal year.

4b (Code:) (Expenses \$ 101,082 including grants of \$ 0) (Revenue \$ 95,783)

The Office of Justice Program grants provide culturally and gender specific programming for disadvantaged Latina youth aged 10-18. The goal of the program is to offer the supports, skills and resources necessary for students to complete high school and continue their education beyond high school. Additional goals are to increase self-esteem and to decrease rates of early or unintended pregnancy. LWPC served 53 disadvantaged Latina youth in Watonwan County with this grant this past year.

United Way and special project funders provide pre-employment and peer counseling services to women in transition who live in south central Minnesota. Services include workshops, individual peer counseling, testing and assessments, advocacy, and resources and referrals. Large populations are low-income women, abuse survivors, single parents and women moving off of public assistance to self-sufficiency. Last fiscal year, LWPC served 182 women in transition and an additional 285 women through special projects and 8 through computer tutoring.

The allocation and monitoring of those funds comply with the requirements of the various grantors. "Client Transportation" was a reimbursement of mileage for class participants to attend classes @ \$0.30 per mile (\$848) and bus tokens and van rentals for participation and outings (\$1,286). The "Snacks" were bought by the staff to provide a lift during group meetings and outings. The "Client Training" and "Books and Materials" were all materials and subscriptions purchased by staff to use during groups. "Client Training" also included \$150 for rental of library space for larger trainings. The "Emergency Stipends" were paid to four parents so that their children could register for activities at school and purchase equipment needed to be participants.
