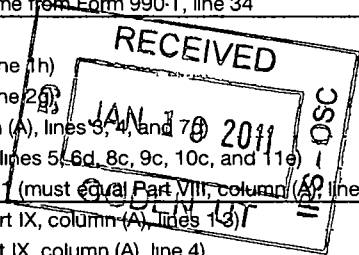

DURING THE PAST YEAR, THE AGENCY SERVED APPROXIMATELY 2,000 TOTAL CLIENTS; 900 CLIENTS IN CASE MANAGEMENT, 350 CLIENTS IN RESIDENTIAL CARE OR SUPPORTED HOUSING, APPROXIMATELY 500 HOMELESS CLIENTS AND 250 CLIENTS IN THE BEHAVIORAL HEALTH CLINIC.
