We are open 6 days a week and our staff and volunteers offer many services for the homeless

including: counseling; job placement assistance; laundry and shower facilities; morning and

afternoon meals; and subsidies to our clients for necessary medical, transportation,

and lodging costs. We also assist with resumes, interviewing skills, and

securing identification and educational documents needed for employment. We also

provide counseling for people who are struggling with addictions and mental illness.

In addition to AA meetings, we have 2 open Bible conversations each day.

These conversations often address issues related to homelessness, addiction, depression, and

related topics. We enabled approximately 80 people to gain employment in the past year.
