Tanager place provides psychiatric, psychological, counseling, and educational services. Our clientele consists primarily of children between the ages of 5-18, with approximately 80% on some type of public assistance.

 Psychiatric Medical Institution for Children. This program provides inpatient treatment services to children with severe behavior disorders. Approximately 120 children are served on an annual basis. For the past year, data indicates that 93% of children discharged had at least partial success with their treatment plan.

**4b** (Code ) (Expenses \$ 1,465,680 including grants of \$ ) (Revenue \$ 1,615,952 )  
 Family Safety, Reunification, and Permanency. This program provides services in a variety of settings that deliver a flexible array of interventions and supports to promote child safety, preservation of the family unit, reduction in the risk of child abuse, enhancement in the capabilities of the caregivers, and promotes reunification for children in out of home placements. Outcome data indicates that on average, 94% of program standards were met during the year.

**4c** (Code ) (Expenses \$ 948,381 including grants of \$ ) (Revenue \$ 1,045,616 )  
 Remedial Services. Remedial Services is a medical based, in-home service program that provides skill building interventions to ameliorate behaviors associated with a psychological disorder that has been diagnosed by a licensed practitioner. After care surveys indicate that 80-85% of families are satisfied with the services received, and felt that the services provided the necessary help.
