Provide emergency shelter and case management services for 119 homeless families and 364 individuals, including 245 children. 101 families moved into a more permanent housing arrangement. 64 families increased their income by at least 10%. 46 women who were seeking employment gained short or long-term employment. 8 women obtained welfare benefits. 58 children needing the service received child care.

Homeless housing and case management services for 28 families with children. 9 families completed the transitional housing program and moved into permanent housing. One family purchased their own home. 80% of the families that completed the program increased their monthly income by 112%. 100% of the adults in the program were employed, in job training, or attending school. 100% of the clients established a savings account. 62% of clients reduced their outstanding bills.

The Board Finance Committee reviews the Form 990 prepared by the certified public accountant with the Executive Director. The Finance Committee approves the submission of Form 990 to the Internal Revenue Service.

Form 990, Part VI, Line 12c - Enforcement of Conflicts Policy

The Conflict of interest policy is approved annually by the Board of Directors. All Board members are required to sign a copy of the policy and disclose interests that give rise to conflicts of interest. The Board addresses any conflicts of interest as needed.

In determining compensation of the Organization's Executive Director, a comparison is done for salaries of comparable positions.
