Present: Mell Meredith (by phone), Bill Kerr (by phone), Steve Lacy, Art Slusark, Joe Ceryanec, John Zieser. Minutes by Cheri Cipperley.

Meeting called to order.

Steve Lacy moved that the minutes of the April 15, 2009 board meeting be approved. Motion seconded by Bill Kerr. Approved unanimously.

FINANCIAL

Two versions of the ten-year asset projection report were reviewed. One report showed projections assuming an annual rate of return of 5%, annual distributions of \$1,500,000 and annual contributions from MDP of \$1,500,000. The other report showed projections assuming the same distributions and contributions, but an annual rate of return of 8%. The group agreed that it was important to keep tabs on the goal in order to reach self-perpetuity.

The fiscal 2010 budget was reviewed. Mell suggested keeping the extra \$50,000 in the matching gift forecast. Matching gifts are currently pretty level compared with last year at this time, but it's early in the year.

The expressions of intent spreadsheet was reviewed. Mell reminded the group of the goal to keep expressions at \$400,000 or under per year. We're in pretty good shape with some room opening up in future years to help the community. Mell reported the Botanical Center is at least three years out from doing a capital campaign. Janis and John Ruan met with Mell to discuss the renovation of the old library for the World Food Expo. She suggested scheduling a tour with Ken Quinn for Art, Steve Lacy, Mell, and Katie Meredith. There was some question as to whether the World Food Prize really fit with the Meredith mission. Cheri will schedule the tour.

UNITED WAY CAMPAIGN REPORT

Steve reported that Dave Kurns, Deb Ohrn and John Zieser did an amazing job with this year's United Way campaign and commented that Meredith employees are really something. A targeted marketing approach was used this year with emphasis being placed on asking employees to contribute \$1.00 per week.

The group agreed that Meredith should accept a naming opportunity, but they wanted to make sure it's a project they wanted to support.
