Free Meals Program In FYE 6/30/10, the Kansas City Rescue Mission served 90,748 balanced and nutritious meals each day to approximately 1,531 unduplicated hungry, generally homeless individuals To supplement our free meals program, we also provided mid-afternoon snacks such as fresh fruit, baked goods and other available foods Receiving a wholesome meal is often the first step toward recovery from addiction and homelessness

Overnight emergency shelter In FYE 6/30/10, the Mission's emergency overnight shelter provided 35,899 beds (total visits) for 1,531 unduplicated people The shelter program is augmented by other on-site services including free clothing, meals, health care, case management, counseling, support groups, chaplaincy and referrals In FYE, 6/30/10, KCRM case managers placed 154 homeless overnight clients in permanent housing, and assisted 53 with employment, 165 with ID and 536 with referrals to mental health and other agencies
