appreciation for staff members by including sponsorships in softball leagues, bowling leagues, volleyball leagues, etc and also flow ers are given w hen losses occur or illness is experienced Memberships in organizations above w hat reimbursement regulations allow help provide a support system and exchange of ideas These types of activities are considered non-allow able costs, yet they help create an atmosphere of caring Staff members are taking leadership roles in memberships in the Kwanis, Qualified Mental Retardation Professional (QMRP) Association, Chamber of Commerce, and the
