

When Catholic Health Initiatives (the parent organization to Carrington Health Center) established its charity care policy it was determined that establishing a household income scale based on the HUD very low income guidelines more accurately reflects the socioeconomic dispersions among the communities in 19 states served by CHI hospitals and health care facilities. In comparing HUD guidelines to the Federal Poverty Guidelines ("FPG"), we find that on average HUD guidelines compute to approximately 200% to 250% (and sometimes 300%) of FPG. Carrington Health Center ("Carrington") bases its charity care eligibility on HUD's 130% of Very Low Income Guidelines based on geography, and affords the uninsured and underinsured the ability to obtain charity care write-offs, based on a sliding scale, ranging from 25%-100% of charges. An individual's income under the HUD guidelines is a significant factor in determining eligibility for charity care. However, in determining whether to extend discounted or free care to a patient, the patient's assets may also be taken into consideration. For example, a patient suffering a catastrophic illness may have a reasonable level of income, but a low level of liquid assets such that the payment of medical bills would be seriously detrimental to the patient's basic financial (and ultimately physical) well-being and survival. Such a patient may be extended discounted or free care based upon the facts and circumstances.

Carrington does not believe that any portion of bad debt expense could reasonably be attributed to patients who qualify for financial assistance since amounts due from those individuals' accounts will be reclassified from bad debt expense to charity care within 30 days following the date that the patient is determined to qualify for charity care. Carrington does not issue separate company audited financial statements, however, this organization is included in the consolidated financial statements of Catholic Health Initiatives. The consolidated bad debt footnote reads as follows: "the provision for bad debts is based upon management's assessment of historical and expected net collections considering historical business and economic conditions, trends in health care coverage, and other collection indicators. Management periodically assesses the adequacy of the allowances for uncollectible accounts based upon historical write-off experience by payer category. The results of these reviews are used to modify, as necessary, the provision for bad debts and to establish appropriate allowances for uncollectible net patient accounts receivable. After satisfaction of amounts due from insurance, CHI follows established guidelines for placing certain patient balances with collection agencies, subject to the terms of certain restrictions on collection efforts as determined by each facility."

CARRINGTON HEALTH CENTER CARRINGTON, ND INTRODUCTION I ORGANIZATION'S MISSION, VISION, AND TAX-EXEMPT PURPOSE

Over 2000 years ago, Jesus Christ issued a call to His followers to heal the sick and comfort the afflicted. This call has echoed down through the centuries and been answered by those who started the religious order that, in turn, founded the hospitals and nursing homes which comprise today's Catholic health care ministry. Each of the men and women who joined these orders also responded to that call to relieve the suffering of their fellow human beings. Today the call is still being answered by the thousands upon thousands of dedicated employees who work in Catholic health care facilities. Many of these committed people may never have even consciously recognized that call. But each, in his own way, has heard it - and responded. The Carrington Hospital Association chartered on September 23, 1915 and built the original hospital in 1916. In 1941, the hospital was leased to the Sisters of the Presentation of the Blessed Virgin Mary of the Diocese of Fargo, ND. Full ownership was transferred to the Presentation Sisters in 1970. Carrington Health Center is comprised of a hospital, built in 1955, currently used for auxiliary and gift shop, physical therapy, and administration, a Rural Health Clinic, a long term care (now basic care) facility built in 1964 and a new hospital complex built in 1986 complete the campus. The Presentation Sisters joined the Catholic Health Corporation of Omaha in 1980 and in 1996, the Catholic Health Corporation consolidated with two other Catholic health systems, the Sisters of Charity Health Care System, Inc., Cincinnati, and the Franciscan Health System, Aston, PA to form a new corporation, Catholic Health Initiatives. The mission of Carrington Health Center and Catholic Health Initiatives is "to nurture the healing ministry of the church by bringing it new life, energy and viability in the 21st Century. Fidelity to the Gospel urges us to emphasize human dignity and social justice as we move toward the creation of healthier communities." Catholic Health Initiative's vision is to live up to our name as one CHI.

Carrington Health Center's vision is to be recognized as one of the best Critical Access Hospitals in North Dakota, and to be known as a hospital that gives the highest quality patient care. The primary exempt purpose of Carrington Health Center is to provide healthcare services to residents in the community and surrounding area regardless of their ability to pay.

II COMMUNITY BENEFIT APPROACH

Carrington Health Center ("CHC") provides a wide array of health services for our area including a Critical Access Hospital, Emergency Care, Trauma Level 5, Acute Care, Swing Bed, General Surgery, Patient Education, Pharmacy, Radiology, Laboratory Services, Physical Therapy, Occupation Therapy, Speech Therapy, Monitored Coronary Care, Respiratory Therapy, Cancer treatments, Same-Day Surgery, Ultrasound, DEXA Scans, CT Scanning, Electrocardiography, Dietetic Counseling, Mammography, a Basic Care Facility, Hospice, and a Full Clinic with 3 Physicians, and 3 Physician Assistants. CHC also has a rural health clinic in Eddy County and had a rural health clinic in Wells County through October of 2010. CHC also assists in addressing the spiritual and emotional needs of Carrington and portions of five surrounding counties. CHC's Mission department, Spiritual Care and Social Services department provide assistance for those needing guidance and help. A clinical psychologist is one of the specialists based at Carrington Health Center's campus. CHC is located in Carrington, ND, Foster County. Surrounding counties served by CHC include Eddy County, and portions of Wells County and Nelson County. According to the U.S. Census Bureau these 3 counties total 2,582 square miles with a population of approximately 11,600 people. CHC has a governing Board of Directors whose membership includes three representatives from Carrington and the immediate surrounding area, two repr

representatives from New Rockford, where a satellite clinic is located, and one representative from Fessenden. The Board also includes two women religious from our founding order, the Sisters of the Presentation of the Blessed Virgin Mary. COMMUNITY ASSESSMENT On April 28, 2009, a Planning Committee met to identify and discuss the top issues facing older adults and persons with disabilities residing in Foster County. This group identified 104 issues important to Foster County elderly and persons with disabilities. The committee narrowed the list to the five most critical issues and a plan was developed to address these issues. In addition, the Healthy Community Initiatives Committee meets once a month under the direction of CHC's Spiritual Care Coordinator working with the school, public health, county social services, churches, community members and other health care professionals. Healthy Community is comprised of community residents and organizations collaborating on projects such as providing supplemental food for individuals or families in need, educational opportunities for residents to learn new crafts and skills, and bringing awareness to healthier behaviors, including discouraging underage drinking and binge drinking. DESCRIPTIONS Our best-known, but often least-utilized, Community Benefit program is the financial assistance we provide to patients who cannot afford to pay for their care. Financial assistance applications are available on our website (www.carringtonhealthcenter.org) and at our facilities. The process is extremely confidential and our goal is to award financial assistance rather than turn patients over to collection for healthcare bills. Charity Care is free or discounted health and health-related services provided to persons who cannot afford to pay for medically necessary health care. Eligibility is based on household income as well as other assets. Consideration is given to a patient who has significant or catastrophic medical bills and does not meet the income guidelines. Charity Care is given to uninsured, low-income patients who are not expected to pay all or part of a bill, or who are able to pay only a portion using an income-related fee schedule. The income benchmark is typically considered to be 130% of the federal poverty level. Community benefit programs for the poor are geared to reducing morbidity and mortality in beneficiaries of Medicaid or state or local indigent programs. COMMUNITY BENEFIT Community Benefit is the name given to the programs we create in response to health needs in our service areas. An important part of our mission is building healthier communities through programs designed to serve the needs of people who are poor and disadvantaged in our community. This type of Community Benefit has the added, positive side-effect of delivering an improved quality of life for everyone. Community Benefit most often takes place outside the walls of our facilities and involves partner organizations in the community. Our Community Benefit activities are designed to:

- * Identify and increase awareness of health needs in Carrington
- * Provide resources to meet those needs
- * Create collaboration between community organizations that focus on health and well-being
- * Tackle problems such as poverty, homelessness, or behaviors (such as domestic violence or underage drinking) that can contribute to poor health.
