	Garrison Memorial Hospital delivers primary health care to a population of approximately 3,600 in McLean County. We operate a 22-bed Critical Access Hospital and a 28-bed skilled nursing facility. We also operate a rural health clinic in Garrison, North Dakota. Our facility employs approximately 165 people. Garrison Memorial Hospital makes medical care accessible to the entire community it serves. It operates a 24-hour, Level 4 state certified emergency room, providing emergency care to all people regardless of their ability to pay. In 2009/2010 we had 1,302 emergency room visits. We also had 406 acute days of care, 4,386 swing bed days, 9,489 days of skilled nursing care, and 5,302 clinic visits. Garrison Memorial Hospital's charity care policy provides discounted and free services to patients who lack the resources to be fully responsible for the healthcare they receive. The Charity Care policy is designed to ensure the population served by Garrison Memorial Hospital has access to needed healthcare services. In fiscal year 2009/2010, Garrison Memorial Hospital and its clinic had \$14,725 in charity care based on charges foregone and \$170,527 in bad debt write offs. Our rural health clinic offers a sliding fee schedule to uninsured and underinsured patients, which is mandated by the National Health Service Corps Program. In 2009/2010, Garrison Memorial Hospital's payer mix was 40% Medicare, 23% Medicaid, 1% Indian Health Services, 12% self-pay and 24% commercial insurance. All payers are charged the same regardless of insurance.

In 2009/2010 she assisted 53 individuals. She is also responsible for our adult preventative programs (diabetes, women's and men's health) by tracking these program services and sending reminders to patients to schedule follow-up visits with 1,628 clients served in 2009/2010. The Rx Assist Program also falls under her job duties where she works with our physicians on specialty medication management. She helped 10 clients in 2009/2010. She also assists patients with Medicare part D and assists with patient education and free screenings that are done at our annual health fairs. She coordinates the clinic's diabetes education program via telemedicine, in conjunction with a diabetic educator at MID Dakota Clinic in Bismarck. Another committee that the Community Resource Coordinator serves on is a Diabetes Task Force sponsored by the North Dakota Department of Health. The task force works to improve access and quality care to diabetic patients. The Community Resource Coordinator also serves on the Mclean County Interagency Committee. This committee works collaboratively with the Mclean County Sheriff's department, county school districts, healthcare entities, and the Mclean County Resource Center on providing access to Social Services and healthcare. The Coordinator also sits on the McLean County Tobacco Task Force. The Tobacco Task Force goal is to decrease access to tobacco, provide education and cessation options for patients and the community. The Community Resource Coordinator also has established access for dental care for uninsured and under insured patients. This is done collaboratively with the dental program at Northland Community Health Center in Turtle Lake, ND. Garrison Memorial Hospital is also part of Partners in Prevention Immunization Program through the North Dakota State Health Department, which allows access to immunizations to all children regardless of ability to pay.

Part VI, Line 6 Garrison Memorial Hospital is governed by a board of directors made up of 5 Benedictine Sisters from the Annunciation Monastery in Bismarck, North Dakota, 2 physicians, 5 community leaders, and the President/CEO of St Alexius Medical Center This board meets monthly to conduct the business of Garrison Memorial Hospital The Hospital has an 8 member advisory board made up of 2 Benedictine Sisters from Bismarck, 1 community member from Max, ND, and 1 community member from White Shield, ND, and the other 4 from the community of Garrison, ND The Hospital extends medical staff privileges to all qualified physicians in the community Surplus funds, if available, are reinvested into the facilities to improve patient care The Hospital operates a 24 hour, Level IV certified trauma center Garrison Memorial Hospital treats all patients regardless of their ability to pay Garrison Memorial Hospital participates in Medicare, Medicaid, ND Women's Way, Caring Program, and ND Healthy Steps Garrison Memorial Hospital participates in education and training of healthcare professionals We participate with the UND School of Medicine as a site for MD interns to participate and complete their rural rotation, under supervision of our physicians Our physicians hosted 6 MD interns in 2009/2010 We also have various nursing students from University of Mary, Minot State University, and a few other colleges In 2009/2010 we hosted 3 nurses completing an internship, and 4 nurses who job shadowed our staff We also have had 1 Physical therapy student that shadows our Physical Therapists a requirement to complete their degree Several of Garrison Memorial Hospital's healthcare professionals share their time and talents with various organizations, which serve for the betterment of our community and state One Physician Assistant serves on a ND Department of Health Tuberculosis Advisory Board, another Physician Assistant serves as a delegate to the ND Medical Association Board Our Director of Nursing serves on the Minot State University Community and Clinical Advisory Committee that seeks to place nursing students in internships She also serves on the ND Department of Emergency Services, Northwest Regional Response Committee that works on emergency response plans to prepare for terrorism and public emergencies In addition to the above activities that the hospital conducts, simply operating a hospital in a small community that serves in a medically underserved area is the community benefit
