An 18-bed Critical Access Hospital is privately located on the second floor of the facility Helping to relieve the added stress of extended travel, the organization is able to provide locally many of the services found at large hospitals Through strong affiliations with major medical organizations, Cooperstown Medical Center is able to provide 24-Hour Emergency Services, Occupational Therapy, X-Ray and Laboratory Services, Electrocardiography, Respiratory Therapy, Incontinence management, Therapy, Physical Therapy, Speech Therapy, Cardiac Monitoring/Telemetry, Chemotherapy, swing bed, and hospice care The Hospital had 1,280 total inpatient days a 48-Bed Nursing Facility provides 24 hour care for individuals with degenerative conditions, dementia, and a variety of medically complex conditions Residents are cared for by a highly trained and skilled staff of professionals, who are , for the most part their friends, neighbors, or family members Nursing home care is available for long-term care stays, convalescent care, and short-term stays Emphasis is placed on a resident's remaining skills, not on lost skills Residents are allowed to retain their independence and dignity with assistance to succeed in daily tasks The Nursing Home had 17,269 bed days of service for individuals The Medical clinic has family practitioners focusing in all major medical areas ranging from pediatrics to gerontology, including gynecology, prenatal and baby care The Medical Clinic had 6,305 clinic visits during the fiscal year
