When Catholic Health Initiatives (the ultimate parent organization to Mercy Medical Center) established its charity care policy it was determined that establishing a household income scale based on the HUD very low income guidelines more accurately reflects the socioeconomic dispersions among the 69 urban and rural communities in 19 states served by CHI hospitals and health care facilities. In comparing HUD guidelines to the Federal Poverty Guidelines ("FPG"), we find that on average HUD guidelines compute to approximately 200% to 250% (and sometimes 300%) of FPG. Mercy Medical Center bases its charity care eligibility on HUD's 130% of Very Low Income Guidelines based on geography, and affords the uninsured and underinsured the ability to obtain charity care write-offs, based on a sliding scale, ranging from 25%-100% of charges. An individual's income under the HUD guidelines is a significant factor in determining eligibility for charity care. However, in determining whether to extend discounted or free care to a patient, the patient's assets may also be taken into consideration. For example, a patient suffering a catastrophic illness may have a reasonable level of income, but a low level of liquid assets such that the payment of medical bills would be seriously detrimental to the patient's basic financial (and ultimately physical) well-being and survival. Such a patient may be extended discounted or free care based upon the facts and circumstances.

Mercy Medical Center does not believe that any portion of bad debt expense could reasonably be attributed to patients who qualify for financial assistance since amounts due from those individuals' accounts will be reclassified from bad debt expense to charity care within 30 days following the date that the patient is determined to qualify for charity care. Mercy Medical Center does not issue separate company audited financial statements. However, the organization is included in the consolidated financial statements of Catholic Health Initiatives. The consolidated footnote reads as follows: "The provision for bad debts is based upon management's assessment of historical and expected net collections considering historical business and economic conditions, trends in health care coverage, and other collection indicators. Management periodically assesses the adequacy of the allowances for uncollectible accounts based upon historical write-off experience by payor category. The results of these reviews are used to modify, as necessary, the provision for bad debts and to establish appropriate allowances for uncollectible net patient accounts receivable. After satisfaction of amounts due from insurance, CHI follows established guidelines for placing certain patient balances with collection agencies, subject to the terms of certain restrictions on collection efforts as determined by each facility."

After having been turned over to a third-party collection agent, any patient account that is subsequently determined to meet the MMC community assistance policy is required to be returned immediately by the third-party collection agent to MMC for appropriate follow-up. Mercy Medical Center requires its third-party collection agents to include a message on all statements indicating that if a patient or patient guarantor meets certain stipulated income requirements, the patient or patient guarantor may be eligible for financial assistance. All of Catholic Health Initiatives' hospitals' contracts with third-party collection agencies include the following standards: Neither CHI hospitals nor their collection agencies will request bench or arrest warrants as a result of non-payment; Neither CHI hospitals nor their collection agencies will seek liens that would require the sale or foreclosure of a primary residence; and No Catholic Health Initiatives' collection agency may seek court action without hospital approval. ORGANIZATION'S MISSION, VISION, AND TAX-EXEMPT PURPOSE Mercy Medical Center (MMC), Williston, ND, is a sole community hospital, which transitioned to a Critical Access Hospital (CAH) effective September 20, 2008. The roots of MMC originated in Dublin, Ireland, where Catherine McAuley established the Sisters of Mercy in 1831. Catherine's mission was to give back to the community by providing for the needs of the poor. In order to bring healthcare to western North Dakota, the Sisters of Mercy founded Mercy Hospital in 1920. Since then, MMC has continued the legacy of giving back to the communities it serves and carrying on the mission of providing for those in need. In 1974, Mercy Hospital moved to its current location at 1301 15th Avenue West. Along with the move came new changes and an expansion of services. Today, MMC is composed of 1) provider-based clinics, including the Craven-Hagan Clinic providing family practice, along with general, orthopedic and ENT surgery, and outpatient Behavioral Health Services, 2) a wide variety of outpatient services including the Leonard P. Nelson Family Cancer Treatment Center, and Mercy Recovery Center chemical dependency unit. MMC provides healthcare for a region with a population of approximately 50,000 and provides employment for nearly 450 people. In 1996 MMC and all of its service lines became a part of the Catholic Health Initiatives (CHI) system. MMC and CHI continue the essential healthcare commitment of its founding congregations. To build healthy communities by caring for the vulnerable, caring for the whole person in body, mind and spirit, and going outside the walls of its facilities to care for people in need. In 2008 MMC transitioned to a Critical Access Hospital (CAH) operating under a 25-bed limit. This transition helped reverse a negative operating margin recorded for 3 consecutive years. In November of 2009, Mercy Medical Center launched a \$5 million capital campaign "Cancer Care Close to Home", which is well underway. To date, \$1.9 million has been raised, of which Mercy employees proudly committed to donating \$275,000 in support of the campaign. The campaign funds will be used to advance the Leonard P. Nelson Cancer Treatment Center. The upgrades will accommodate the steady increase in patient volumes, due to an aging population and will include the purchase of a new linear accelerator which will provide enhanced treatment technology delivering greater precision and results. The mission of MMC and CHI is to nurture the healing ministry of the church by bringing it new life, energy, and viability in the 21st century. Fidelity to the Gospel urges us to emphasize human dignity and social justice as we move toward the creation of healthier communities. Our Core Values are: Reverence, Profound respect and awe of all of creation, the foundation that shapes spirituality, our relationships with others and our journey to God. Integrity. Moral wholeness, soundness, fidelity, trust, truthfulness in all we do. Compassion. Solidarity with one another, capacity to enter into another's joy and sorrow. Excellence. Preeminent performance, becoming the benchmark putting forth our personal and professional best. Our Vision is to live up to our name as One CHI. Catholic. Living our Mission and Core Values. Health. Improving the health of the people and communities we serve. Initiatives. Pioneering models and systems of care to enhance care delivery. It is MMC's goal to hold true to our Core Values of Reverence, Integrity, Compassion, and Excellence, and in doing so we strive to partner with regional organizations, agencies, and entities to provide community benefits so that together we can build a healthier community. The following report outlines the community benefits and services MMC has provided to the region this past year. As a non-profit Catholic healthcare organization, we treat patients regardless of their ability to pay. This is consistent with our Mission and Core Values. In addition, MMC provides thousands of dollars in resources, including time and contributions, to many organizations throughout the region. Community service has been a vital component of MMC since its inception. MMC operates a 24-hour emergency room 365 days per year. That emergency room is open to all individuals regardless of their ability to pay. Mercy has an open medical staff, p

participates in Medicare and Medicaid, and has an active charity care program MMC is included in the Official Catholic Directory as a tax-exempt hospital COMMUNITY BENEFIT APPROACH Throughout its history MMC has been intimately involved in community health collaboration and has played a key role in evaluating area health issues, setting priorities and plans for improvement Mercy continues our deep commitment and involvement in the community health collaborative today Process Mercy Medical Center's Community Benefit Plan is based on our understanding of unique community needs derived from collaborative needs assessments, focus groups, and surveys conducted with our community partners It is generally recognized that the health of the community is not the responsibility of any one entity, but rather requires the coordinated efforts of many entities - public and private - to realize an improved health status of a community MMC has been working with public and private entities in our service area to measure and improve the health status of the community The most recent assessment, completed in 2004, reflects the compilation and analysis of extensive data sources to identify issues having a significant impact on the health and general well being of area residents Information relating to community health issues were gathered from four focus groups There were 32 participants including nine consumer representatives, six health care providers, ten business and industry representatives, and seven clergy and religious leaders Focus group participants were asked to identify those segments of the community that do not have ready access to health care services, the types of services they have difficulty accessing, the root causes behind these access issues, and gaps in the services that could be addressed to better meet these access needs Summary of Assessment Findings All four of the groups had individuals that expressed gratitude for the hospital and primary care services that are available through Mercy Medical Center and its physicians They believed that existing access-to-care issues can be improved through community collaboration Most participants remarked that access to health care in Williston is not an overwhelming problem, but one that is certainly challenged by the community's remote location in western North Dakota Nine key factors having the greatest impact on the overall well ness of the area emerged in the review Ready Access to Primary Care, Ready Access to Specialty Care, Ready Access to Quality Care, Availability and Cost of Health Insurance, Denial of Care, Charity Care, Access to Affordable Prescription Drugs, Access to Home Care, Adult Day Care, Assisted Living and Transportation, and Access to Adequate Parenting and Appropriate Home Care Our next assessment is scheduled to begin early in 2011 Uncompensated Care for the Poor During the fiscal year ending June 30, 2010, MMC provided benefits to the poor in our community of \$2,089,531 as indicated above Approximately 41,055 people benefited from these services As a non-profit healthcare facility, Mercy provides healthcare services to all those in need, regardless of their ability to pay MMC recognizes the variance between its cost and reimbursement for services provided when quantifying its charity care benefit For fiscal year 2010, MMC provided \$1,100,707 in discounts to the uninsured and underinsured QUALITATIVE DESCRIPTION OF COMMUNITY BENEFIT Community Outreach for the Poor Mercy Rider Program The Mercy Rider Program began operations in 1990 as a program to assist women and children with transportation to doctor's appointments Since then, it has grown into a program that assists those with very low income, which includes adults and children, disabled, and the elderly This program provides much needed transportation assistance in the community for individuals who would otherwise have significant challenges relating to essential transportation Indi

Mercy Medical Center includes information concerning its financial assistance policy on its website. In addition, MMC prominently displays its charity care policy in both English and Spanish in obvious locations throughout the hospitals, including the emergency rooms and other patient intake areas, as well as in MMC outpatient facilities. In addition, Mercy Medical Center registration clerks are trained to provide consultation to those who have no insurance or potentially inadequate insurance concerning their financial options including application for Medicaid and for financial assistance under MMC's charity care policy. Upon registration (and once all EMTALA requirements are met), patients who are identified as uninsured (and not covered by Medicare or Medicaid) are provided with a packet of information that addresses the financial assistance policy and procedures including an application for assistance. Mercy Medical Center registration clerks read the organization's medical assistance policy to those who appear to be incapable of reading, and provide translators for non English-speaking individuals. MMC's staff will also assist the patient / guarantor with applying for other available coverage (such as Medicaid), if necessary. Counselors assist Medicare eligible patients in enrollment by providing referrals to the appropriate government agencies.

Mercy Medical Center, along with its affiliated outpatient facilities are part of Catholic Health Initiatives. Catholic Health Initiatives (CHI) is a national faith-based nonprofit health care organization with headquarters in Englewood, Colorado. CHI's exempt purpose is to serve as an integral part of its national system of hospitals and other charitable entities, which are described as market-based organizations, or MBOs. An MBO is a direct provider of care or services within a defined market area that may be an integrated health system and/or a stand-alone hospital or other facility or service provider. CHI serves as the parent corporation of its MBOs which are comprised of 73 hospitals, 40 long-term care, assisted- and residential-living facilities, and two community health-services organizations. Together, these facilities provided \$590 million in charity care and community benefit in the 2010 fiscal year, including services for the poor, free clinics, education and research. CHI provides strategic planning and management services as well as centralized "shared services" for the MBOs. The provision of centralized management and shared services - including areas such as accounting, human resources, payroll and supply chain -- provides economies of scale and purchasing power to the MBOs. Cost savings associated with centralized services for the fiscal year ended June 30, 2010 include more than \$105 million in supply chain expense, approximately \$30 million for insurance costs and more than \$3.9 million as the result of a system-wide effort to coordinate and negotiate technology and equipment purchases. The cost savings achieved through CHI's centralization enable MBOs to dedicate additional resources to high-quality health care and community outreach services to the most vulnerable members of our society.
