Surplus funds, when made available by the UMC Foundation, are used to purchase equipment or make purchases to improve the building structure for the purpose of improving patient care. UMC offers 24 hour access to emergency room care, which is available to all individuals, regardless of their ability pay for the care. UMC offers acute care, swing bed care, general surgery, as well as many outpatient services. UMC does not engage in scientific or medical research. UMC does participate in education of healthcare professionals. We take approximately 2-3 medical students per year and several Physical Therapy students throughout the year from the University of North Dakota. We do training for students from technical schools, as well, as requested. UMC is the only hospital and clinic in the community, therefore, we are a viable part of this community. UMC offers programs such as diabetes screenings, flu vaccination clinics, free blood pressure checks, KIDS UMC (education for young children), etc. UMC also has a representative on the Mayor's Committee of Wellness for the community. UMC brings in specialty doctors to our clinic in order to offer more necessary services to our patient population, i.e. oncology, psychiatry, etc. We offer volunteer opportunities for high school students and adults. We have twenty members of our UMC Auxiliary Services that volunteer here every week for the benefit of the facility.
