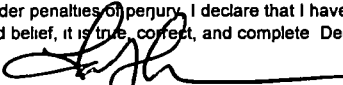
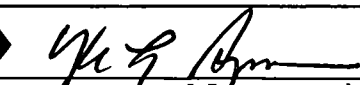

Based on the original application for exemption, the Internal Revenue Service (IRS) determined that the organization qualified as a tax-exempt organization under section 501(a). The IRS also determined that the Foundation can reasonably be expected to be a publicly supported organization described in sections 509(a)(1). Under these sections the support percentage should be at least $33\frac{1}{3}$ percent to qualify automatically as a "publicly supported" organization. If the support is between 10 and $33\frac{1}{3}$ percent, the organization may qualify as "public" if facts and circumstances tests in Regulation 1.170A-9(e)(3) are met. The organization has dropped below the required automatic level for the last two years, but has continued its attempt to secure additional contribution support to bring its support percentage to the required level.
