RESIDENTIAL AND FOSTER CARE - The Home serves children and youth from infancy to age 21, as the only agency to provide emergency and temporary care for abused, neglected, or abandoned children in Sedgwick County. The Children's Home provides safe environments that allow children the opportunity to begin healing from their trauma. Children and youth may be admitted by law enforcement officers, social workers, parents and the youth themselves. The Residential departments provide shelter services for youth from 13 to 17 years of age. Our Family Foster Care department has identified special families in the community for care of children, ages 0 to twelve years. PREVENTION AND TRANSITIONAL - Our BRIDGES program serves teens and young adults, ages 16 to 23, who are runaway, homeless or in state custody. The goal is to help these BRIDGES participants reach self sufficiency. Many of these teens and young adults have children of their own. Our Street Outreach Services program is designed to take resources directly to at risk youths on the street. SOS staff provide access to a comprehensive array of services such as crisis intervention, counseling, shelter, health services and runaway programs. And, the Child Access program provides monitored child exchanges between custodial and non-custodial parents and supervised visits for non-custodial parents and their children.
