Tax regulations within each jurisdiction are subject to the interpretation of the related tax laws and regulations and require significant judgment to apply. With few exceptions, the Organization is no longer subject to income tax examinations by the applicable tax authorities for the years before 2007. If any were to be incurred, the Organization's policy is to record penalties and interest assessed by income taxing authorities as operating expenses.
