The organization has met the 33 1/3% support test in the past and is well over the 10% support test for the last 4 years. The contributions to this entity come from a variety of individuals and businesses in the Ashland area. The community of Ashland is home to approximately 900 residents which benefit from this foundation. As in every small community, there are only a limited number of people with sufficient resources to make large contributions. The foundation carries on activities for the community such as the lucky ducky races which allow community members to purchase ducks to raise funds. The foundation provides grants and scholarships to a variety of organizations and individuals within the Ashland community. The board is made up of various members of the community and do not represent just one business or organization. The treasurer is a local accountant that maintains the books for the organization.
