The mission of the Foundation is to develop resources to enhance and expand educational opportunities, to create long-term permanent investment funds for the purpose of generating annual income and to encourage community understanding and support for the Leavenworth Public Schools.

Innovative Teacher Grants \$37,934: Each year the Foundation funds innovative grants for teachers or district employees which are classroom, building or district wide programs. The Foundation is interested in grants that impact large numbers of students. The best of those grants can turn into permanent programs in the district such as the Pioneer Pride program at the high school or the WATCH D.O.G.S. Dads at the elementary and intermediate schools. The Pioneer Pride program is a student led program which motivates students through assemblies where students are recognized for GPA, attendance and good behaviors. All numbers in these areas have improved since the program was implemented. WATCH D.O.G.S. (Dads of Great Students) encourages dads to come into the schools to participate in activities that are academic, on the playground, in the lunch room or where he is needed. It is a great opportunity for kids from single parent families to interact with a male role model.

4b (Code:) (Expenses \$ including grants of \$) (Revenue \$)
First National Bank Horizon History Journey \$10,000: The purpose of this program is to ensure that when our students graduate they will have had an opportunity to learn from experiential learning trips to area museums that support Kansas and US history curriculums. Students 4th through high school may visit the Carroll Mansion, the Carousel Museum, First City Museum and the Richard Allen Cultural Center in Leavenworth; the Buffalo Soldier Memorial and Frontier Army Museum at Fort Leavenworth; the Arabia Steamboat Museum, Harry S. Truman Presidential Library, and Liberty WWI Memorial in Kanas City; and the Kansas History Museum, the State Capitol, and Brown Versus Board of Education Museum in Topeka.

Kiwanis Reading Award \$10,000: This program recognizes the "most improved readers" in 4th, 6th and 8th grades. Winning students are honored at the Foundation Breakfast where they receive certificates. Their school libraries receive \$1,000 to purchase books; each book is labeled on the inside cover with the honored student's name. Their names are also engraved on a plaque that hangs in the entryway of their school. This is a great encouragement to students who might not be the best readers, but the most improved.
