The District conducts numerous educational programs for Rotarians. These include the Membership Seminar, the Rotary Foundation Seminar, the Youth Services Seminar, the Ethics Seminar for young people, the District Assembly (where Rotarians learn how to run their clubs), the District Conference (where Rotarians learn about the accomplishments of their fellow Rotarians both locally and worldwide), the Rotary Academy (where Rotarians learn how Rotary functions in depth), and President Elect Training Seminar.

All expenses of Rotary District 5190 (Part CA and part NV) District Governor, District Governor Elect and District Governor Nominee were paid for the current year (July 1, 2009 to June 30, 2010). The District consists of approximately 2,500 members in 54 clubs providing service to others, promoting high ethical standards, advancing world understanding, goodwill, and peace through fellowship of business, professional and community leaders. The District supports and educates the club members and leadership in this endeavor.
