

OF

**ARTICLE 1
NAME - MISSION**

1.1 The name of this organization shall be "Aquinias Catholic Schools Foundation, Inc.", which is a non-stock, non-profit, and tax exempt 501(c)(3) corporation (hereinafter referred to as "Corporation").

1.2 The mission of the Corporation is to promote and ensure that high quality Catholic education is made affordable and accessible to all in the La Crosse Deanery through the Aquinas Catholic Schools. The mission is accomplished by ensuring that donors' funds are spent according to their wishes, by investing entrusted donations in a prudent and effective manner to maximize their benefit, and through active fund raising that maintains the affordability of a Catholic education for all families who desire one.

**ARTICLE 2
MEMBERS AND BOARD OF DIRECTORS**

2.1 Members and Board of Directors.

A. There shall be no members of the Corporation.
