THE PROPERTY ALSO HAD A MORTGAGE WITH A LOCAL FINANCIAL INSTITUTION WHICH TOTALED \$42,130 AS OF 6/30/2010. THIS DEBT WAS TRANSFERRED WITH THE PROPERTY FOR A NET FMV OF THE PROPERTY OF \$147,770. THE PROPERTY AND EQUIPMENT IS IDLE AND THE INTENT OF THE ORGANIZATION IS TO SELL THE PROPERTY.
