Accordingly, no provision or liability for income taxes has been included in the accompanying financial statements. The Endowment adopted the provisions of FASB Accounting Standards Codification (ASC) 740, Income Taxes, on July 1, 2009. ASC 740 requires that the Endowment recognize the financial statement benefit of a tax position only after determining that the relevant tax authority would more likely than not sustain the position following an audit. For tax positions meeting the more-likely-than-not threshold, the amount recognized in the financial statements is the largest benefit that has a greater than 50% likelihood of being realized upon ultimate settlement with the relevant taxing authority. The Endowment is subject to income tax regulations in the U.S. federal jurisdiction and certain state jurisdictions. Tax regulations within each jurisdiction are subject to the interpretation of the related tax laws and regulations and require significant judgment to apply. With few exceptions, the Endowment is no longer subject to income tax examinations by the applicable tax authorities for the years before 2007. If any were to be incurred, the Endowment's policy is to record penalties and interest assessed by income taxing authorities as operating expenses.
