BOTH THE SIZE AND NUMBER OF PROTECTED AREAS IN THE CONGO BASIN HAVE INCREASED IN RECENT YEARS, THOUGH THE REGION'S BIODIVERSITY-RELATED TOURIST SECTOR REMAINS UNDERDEVELOPED, ACCORDING TO FORESTS OF THE CONGO BASIN: STATE OF THE FOREST, A BIENNIAL REPORT PUBLISHED BY THE CONGO BASIN FOREST PARTNERSHIP (CBFP).
