Residential Bello Machre enriches the lives of children, teens, adults, and seniors with developmental disabilities through loving care, guidance, and opportunity so that they can live life to its fullest Bello Machre opened two new homes welcoming seven new individuals into its caring residential family, two of these individuals were moved from a nursing home facility and one individual was removed from an unstable home environment Bello Machre graduated its 9th in-house Certified Nursing Assistant class This training ensures our individuals receive the best care possible while empowering our employees through higher education A comprehensive Emergency Preparedness Plan was put into operation ensuring the security and safety of the individuals served during an emergency situation This plan was tested to the limit with multiple winter blizzards during December and February By sharing their time and talents, volunteers at Bello Machre continue to make a difference in the lives of those served 80 active volunteers performed over 1,900 hours of service and five community groups performed over 1,700 hours at homes including yard clean up and landscaping
