House of Ruth serves women, children and families who are facing most severe problems with the fewest resources. Driving the challenges in their lives, (homelessness, domestic violence, mental health problems, addiction, poverty, etc.) is the repeated, sustained trauma of countless experiences of abuse, beginning in the childhood and persisting to the present. Helping women, children and families in greatest need throughout the District of Columbia since 1976, House of Ruth provides a comprehensive array of housing, services, and support in nurturing environments.

Housing and Services for Women - There are five transitional and permanent housing programs that focus on helping 109 women who are homeless build the capabilities and skills to cope in a healthy way, managing their mental illness and avoiding addiction. The Organization engages these women, helps them connect to other resources in the community and encourages them to participate in more extensive services.

Housing and Services for Families - House of Ruth serves 74 families and 200 children at six residences. The families receive many services organized to meet the needs of each family member. The mothers pursue an active schedule of recovery work, positive child-rearing and learning skills of living independently. The children attend school or day care and receive extensive counseling and mentoring.

Community Services - The 76 children living at House of Ruth residences and in the community benefit from the therapeutic services provided at the Child and Family Development Center, where they get the specialized help they need to overcome developmental delays. The Domestic Violence Support Center provides outreach and counseling to women and their children who are dealing with domestic violence. This center serves approximately 400 women on an annual basis.
