The mission of HH MedStar Health is to serve our patients, those who care for them, and our communities. HH MedStar Health is part of a regional healthcare system that operates nine hospitals, providing healthcare services in Maryland and the Washington, D.C. region. It is the area's largest health system and one of its largest employers, with more than 26,000 associates and 5,300 affiliated physicians. Areas of clinical excellence include cardiology, cardiac surgery, oncology services, rehabilitation, neurosciences, sports health, orthopedic surgery, women's services and emergency and trauma services. HH MedStar Health's comprehensive services include primary, urgent and subacute care, medical education and research. Other health-related services include assisted living, home health and long-term care. MedStar Health also operates nursing homes, senior housing, rehabilitation, ambulatory centers and a physician network. In fiscal year 2010, HH MedStar Health's hospitals had 161,890 inpatient admissions.







