Byte Back's mission is to improve economic opportunity for low-income residents of the Washington DC area by providing computer training and employment readiness skills

	Byte Back offers a wide range of computer training, from basic computer literacy to information technology (IT) certification courses, as well as job readiness skills and job placement assistance. Instructors are volunteers. Low-income students receive free instruction and a free refurbished computer upon graduation. During fiscal year 2010, Byte Back taught classes to more than 1,000 students, up from 442 the year before. In 2010, Byte Back won Honorable Mention for the Washington Post Award for Excellence in Nonprofit Management and was selected for inclusion in the 2010-2011 Catalogue for Philanthropy. For more information see Schedule O. Byte Back offers three basic programs: (1) Computer literacy courses for students with no previous experience with computers. Students learn how to use the computer to apply for jobs, correspond with institutions, manage their health and finances, and participate in their community and government. (2) Microsoft Office course which includes instruction in Microsoft Word, Excel, PowerPoint and Outlook, as well as job readiness training. Each graduate receives a free refurbished computer. (3) Certification. Byte Back provides three programs designed to prepare students for computer certifications including IC3, A+ and MCAS. In the coming months the organization will add MS Project, Net+ and Linux and plans to add IT security certification with the year. The computer repair/recycle/reburbish program prepares students to start their own home-based neighborhood computer repair shop.
