


Farmers & Hunters Feeding the Hungry, Inc. establishes and maintains local programs in states nationwide. Developmental resources, training and support are provided to volunteers who coordinate the program locally in their state. The Organization compensates licensed, health inspected, meat-processing facilities to process deer and other game animals donated by hunters and landowners into frozen packages of nutritious red meat. The packaged meat is then distributed free of charge to food banks, pantries, and ministries that serve the needy. Approximately 214 tons of meat was provided this year yielding 1.72 million meals. Just one deer can provide up to 200 servings of meat for hungry men, women and children. This is significant given that one in five American children go to bed hungry on any given night. Farmers & Hunters Feeding the Hungry, Inc. is comprised of a national headquarters along with numerous local and state programs nationwide. Details regarding program activities, income and expenses are available upon request.
