

Activities & Governance	1 Briefly describe the organization's mission or most significant activities Central Scholarship Bureau (CSB) provides need-based financial aid in the form of grants and interest-free loans to Maryland residents pursuing postsecondary education. Postsecondary programs include vocational training, two-year and four-year undergraduate degrees, and graduate studies. CSB conducts extensive outreach activities to students, parents, high schools, private career schools and colleges to inform them about funding available at CSB. CSB seeks to help students and families make informed financial choices about postsecondary education. In 2009, CSB processed close to 2200 student applications and committed approximately \$1 million to about 200 students. At any point in time, CSB manages about \$3 million in interest-free loans to around 600 students.



